Minutes | March 12, 2024

Welcome | At 7:00 p.m. Courtney Shuster welcomed in-person and online guests to the Annual Meeting of the Congregation of Christ Church of Oak Brook.

Call to Order | At 7:01 p.m. Rev. Dr. Daniel Meyer, Lead Pastor of Christ Church of Oak Brook, called to order the 2024 Annual Meeting of the Congregation of Christ Church of Oak Brook and noted for the record that Minutes of the meeting were being recorded by Trustee Kevin Anetsberger, Secretary of Christ Church. Rev. Dr. Meyer noted that while friends of the church are welcome to attend the meeting, voting is reserved for confessing members of Christ Church.

Approval of Minutes | A motion was made and duly seconded to approve the Minutes of the March 14, 2023, Annual Meeting. Minutes were approved by a unanimous vote of members.

Worship and Prayer | Rev. Tracey Bianchi called the members to worship with the words of Psalm 73. Members continued in worship through song, and were lead in prayer by Trustee nominee Stephanie Oldenkamp Bruzan.

Lead Pastor's Report | Rev. Dr. Meyer noted that this would be his final report as Lead Pastor of Christ Church of Oak Brook. He encouraged the members to pray for the next person to fill that role, their family and for the senior leaders conducting the search. He highlighted the church's progress over the past year, including hiring Disabilities Ministry Director Danielle Shaffer and Preschool Director Kelly Newton, renovating preschool rooms, and beginning a major renovation project for the children and student ministry spaces. Meyer presented a slide show depicting the new spaces. The church has also completed various maintenance projects, upgraded equipment and reduced mortgage debt. He emphasized the church's role in the broader Christian community and shared his excitement for the upcoming year. Meyer also noted that there is still much work for him to do here as we finish the LIFT Initiative and fulfill the LIFT Vision and presented a video showcasing stories of God's impact through Christ Church on individuals' lives over the past year.

Following the video, Meyer expressed gratitude for the congregation's involvement in the church's ministries and acknowledged the impact of their service. He introduced the First Impressions Ministry's new initiative, Discover Christ Church, which provides a behind-the-scenes look at the church's operations and has inspired participants to contribute their gifts. Meyer thanked the church staff, highlighting their character, dedication, and skills, and expressed confidence in the church's future under the leadership of the Senior Leadership Team and the next lead pastor. He specifically acknowledged Rob Kastens, the Executive Pastor, for his role in coordinating the Senior Leadership Team. Meyer also recognized the church's boards, the Board of Trustees and the Board of Elders, for their leadership in the LIFT initiative. He invited the staff members present to stand and be acknowledged, expressing his joy in working with them.

Trustee Board Report | Trustee Board Vice-Chairman Tim MacKenzie began by explaining that the Board of Trustees is responsible for financial, administrative and strategic duties at Christ Church. They have been working with Rev. Dr. Dan Meyer and the senior leadership team on the five-year Strategic Plan and the two-year LIFT initiative. The Trustees are encouraged by the congregation's financial support and urge them to maintain their stewardship. The church's Institutional Fund reserves have increased to \$6.5 million and the Trustees manage these funds carefully. They have renewed their partnership with PhilanthroCorp Consulting Group for the Intentional Legacy Giving Ministry, which has resulted in over \$7 million in gifts to the church.

In recent months, the Trustee Board has focused on planning for the upcoming leadership transition, reviewing the church constitution and evaluating the board's structure and composition. They are committed to presenting a lead pastor candidate for membership approval. A dedicated Trustee

prayer team, a church leader group and a search team have been formed for this process. A consulting firm, The Ligon Group, has been engaged to develop a profile for the next lead pastor and a search firm, The Slingshot Group, has been engaged to conduct the search itself. The Trustees aim to have the new lead pastor in place later this year, with an overlap period with the current lead pastor, Dan Meyer, until January 2025. Dr. Meyer will then serve as Lead Pastor Emeritus until December 2025.

The Trustees acknowledge the importance of the Christ Church Constitution and have amended it in the past to enhance its effectiveness. They will continue to review it during the leadership transition. The Trustees also strive to build a diverse and effective board, and MacKenzie introduced the four nominees for Trustee positions. MacKenzie expressed gratitude to the retiring trustees Ron Oldenkamp, Deborah Borsum and Maureen Condon for their service and dedication to the church and shared his personal remembrances of working with each of them.

Treasurer's Report | Trustee Kevin Waden, Treasurer of Christ Church, began by thanking the congregation for their continued support of the church, which has enabled the church to provide excellent programming and missional support. The LIFT initiative, which aims to collect \$31.7 million, has so far collected over \$20.15 million, with 370 new givers donating more than \$400,000. The church has been able to reduce its debt by \$565,000 and has a floating rate mortgage of \$7.4 million of which \$5.6 million has an interest rate cap of 3.66% which has saved the church over \$200,000 as interest rates have risen. The church also has a \$1.5 million line of credit, which it has not used due to healthy cash flows.

In 2023, the church collected just under \$17 million, an increase over anticipated giving. Along with proactive expense management by staff and ministry leaders this resulted in a surplus of \$4.5 million for operational year 2023. For 2024, the church expects donation income of \$14.7 million and has proposed an operational budget of \$11,432,000. Key drivers of the budget increases include costs to reopen the preschool, filling key positions, cost of living increases for staff, and growth and benefit costs. To achieve a balanced budget in 2024, the church anticipates using the previously mentioned \$4.5 million 2023 surplus and approximately \$1 million of its reserves. Treasurer Kevin Waden then asked for approval of the 2024 operating budget, which is required to be approved by the congregation. The motion was seconded, and the budget was approved unanimously by both in-person and online members.

Elder Board Report | Vice Chair of the Board of Elders and Chair of the Elder Council David Lacine recognized retiring members from active duty on the Board of Elders, the Diaconate, and the Board of Trustees.

Lacine then offered a prayer, asking for God's guidance and preparation for the coming season. The purpose of the Board of Elders was explained, which includes advising the senior pastor and staff on spiritual and fiduciary matters, administering sacraments and governing the mission's ministry. Lacine presented the nominations for new elders and trustees:

For first term on Board of Elders | Edwin Campos, Claire Maly, Dirk McCoy, Mike McCurry, Allie Noble, Mark Schuster and Jill Tenery

Rev. Dr. Meyer also addressed a question about occasionally adding newer members to the governing boards, emphasizing the importance of having diverse voices and perspectives. Meyer then opened the floor for questions before moving and receiving a second to elect the new slate of Elders and Trustees. A vote was taken and the motion passed unanimously. Newly elected Elders and Trustees were asked to stand and be recognized.

Meyer explained the Board of Elders is also involved with the diaconal ministry and asked Elder Vice Chair Dave Lacine back for further remarks. Lacine expressed excitement for the potential of the next season in the church. The list of deacons and deaconesses was displayed, and Lacine explained that it is the role of the Board of Elders to elect members of the Diaconal board. Lacine encouraged everyone to pray for insight and wisdom during the upcoming transition, emphasizing the importance of prayer as a foundation for the church. Meyer mentions that a group of people, including Dave and Tim, pray for the church every Sunday morning, and invites anyone interested to join them. Meyer expresses that the church's mission outreach is highly valued, as they focus on sending people out into the world to be witnesses for Jesus in various spheres and invites Peter Celauro, Senior Director of Missional Living to the podium.

Missions Report | Peter Celauro explained that in 2023, Christ Church had an exceptional year in mission ministries and offered highlights. Church members filled more than 1,500 volunteer roles in various ministries, such as the food pantry, Gospel Justice Center, Global Outreach teams, and Chicagoland Day of Service. The church provided disaster relief to thousands of people affected by natural disasters and war, and the food pantry ministry served over 1,400 families. Through the For Christmas giving initiative, nearly 1,300 presents were donated to children and \$82,000 was raised for special projects. In addition, \$1.25 million was allocated to support Kingdom work locally and globally. Celauro emphasized that the mission of God is not just about numbers, but about the stories of the global church relieving suffering, transforming communities and living the Great Commission. A video was shown to demonstrate the impact of our support for our sisters and brothers in Malawi. Celauro closed by expressing gratitude for the church's generosity and the impact it makes around the world.

Open Discussion | As stipulated by the Constitution of Christ Church, the congregation was invited to present other matters appropriate to the forum to be addressed by the Board of Trustees or the Board of Elders. Members of the Board of Trustees and the Vice Chair of the Board of Elders were invited by Rev. Dr. Meyer to join him on the platform. Questions regarding the future of our Classic Worship service, the future of our Butterfield campus and the opportunity to participate in focus groups for the lead pastor search were fielded.

Closing Prayer | Closing prayer was offered by Executive Pastor Rev. Rob Kastens.

Adjournment | As Rev. Dr. Meyer closed the meeting, he invited the congregation to visit the Atrium for refreshments and fellowship. Meyer adjourned the meeting at 8:40 p.m.

Lead Pastor's Report

For the Year of our Lord's Grace Two-Thousand and Twenty-Four

The Lord bless you and keep you; the Lord make His face shine on you and be gracious to you; the Lord turn His face toward you and give you peace!

NUMBERS 6:24-26

My Beloved Friends and Co-workers in Christ,

As I conclude this treasured great opportunity to serve as your Lead Pastor, allow me to reflect on how God's grace has been evident during Christ Church's second pastorate:

- The church's **mission, vision, values** and **disciple-making model** were freshly defined as a north star for our second season of influence.
- Our **Elders' Ministry** was re-organized and our **Trustee Ministry** migrated to a Board governance model.
- Our church's longstanding commitment to **classic worship and music** was preserved, the choir expanded to an historic size, and a wide array of concerts filled the Sanctuary to overflowing.
- New **contemporary worship** services were introduced to complement traditional ones, resulting in significant growth in overall weekend attendance, especially among younger families.
- **Female pastors** were added to the staff and **female elders** increased to approximately 50% of the Board.
- An elder-led ministry was established (CommUNITY) to advance our church's inter-cultural character and competence and, especially after the COVID pandemic, the church became substantially more **multi-racial**.
- A refreshed focus was given to developing a **First Impressions** ministry that put **hospitality at the heart** of Christ Church, supported by many more volunteer teams, a variety of facility renovations and refreshment improvements.
- A new **Food Service Ministry** was established, led by a staff director.
- A single, unified approach to **spiritual growth** for all ages was developed/implemented to provide:
 - **Sight for the Pathway** | through vision-casting and growth-planning tools
 - **Training for the Soul** | through resources for practicing spiritual disciplines
 - **Equipment for Life** | through classes and conferences aimed at Christian living
 - **Partners for the Journey** | through small groups and midsize communities
- Our **children's and student ministries** were revitalized and regained their place as the pre-eminent youth programs in the near western suburbs, well-supported by renovated facilities.
- The church became host to the largest **Men's Bible Study Fellowship...Young Mother's Program (MomCo)...Women's Bible study (Women of Hope)...and (for a season) Singles Ministry (Ascend)** in the region.
- A **Stephen's Ministry** was launched to expand the lay caregiving ministry of the church.

- Our **support and recovery ministries** were expanded to provide help for people dealing with addiction, grief, divorce, cancer, job transition, mental illness and other difficult life issues.
- The **ASK Ministry** was started to offer advocacy, support and knowledge to older adults and caregivers.
- Our **Disability Ministry** was expanded from the Friendship Bible Class to many other supportive systems.
- The **Greenhouse Ministry** was established to provide a place of fellowship and equipping for older adults.
- Our church's outreach grew to embrace some 70 domestic and global **mission partnerships** in more than 40 countries.
- A **domestic mission** strategy and staffing model was developed, resulting in a dramatic rise in local voluntarism.
- The church joined a **global missions consortium** with College Church, Wheaton Bible Church, and Moody Church and significantly expanded its **short-term mission** team ministry.
- The **Spirit Village** alternative Christmas market was founded, bringing our mission to life for children and generating an additional \$2.6M in support for missionary projects to date. This outreach morphed into the **Oh What Fun! Christmas Party** in 2022 in an effort to reinvent the event to engage younger families.
- Major **mission grants** (in excess of \$75K apiece) were made to Wycliffe Bible Translators, Chicago's Inner City Impact ministry and to complete the Stephen's Children high school in Cairo, Egypt.
- The church partnered with World Vision on a variety of initiatives (e.g. the AIDS Experience, Team World Vision, Vision Tours) that resulted in some 300 child sponsorships, multiple clean water wells and the construction of a school in Namanjivara, **Mozambique** (an overall investment of approximately \$2.2M)
- Significant new life-changing projects were launched with urban and rural mission partners in **Kenya**.
- The congregation launched its first **multisite** branch (2017) and a second seven-acre campus was purchased from the Fountain of Life Church in unincorporated Lombard (2019) to house **Christ Church Butterfield**.
- Voluntarism in a local **food pantry and food-packing events** increased, providing tens-of-thousands of meals to needy households in DuPage County and abroad.
- A Christian community development initiative (**Resilient**) was launched in the Roosevelt Road Corridor and many volunteers engaged in tutoring, mentoring, and job-training at-risk kids and families. (2018)
- A multi-service providing **Lift Center** was established at our Butterfield campus (2025) to better our food ministry and to cluster around it a variety of other people-developing ministries (e.g. Administer Justice)
- Overall giving to **external mission outreach** causes during the Second Season totaled well over \$30M.
- The church became a satellite site for the **Global Leadership Summit**, resourcing more than 400 influencers annually. We then suspended our involvement in the wake of the allegations and abuse revealed at Willow Creek Community Church and the Willow Creek Association, and the thousands of women that shared their MeToo and ChurchToo experiences.

- From a context where there was no digital ministry (no network, internet, or screens) a state-of-the art **media and communications** ministry was developed, moving the church beyond its historic print, radio, and TV channels into the worldwide web, HD video, livestreaming, social media, handheld devices and digital marketing.
- A modern, multi-dimensional **human resources** infrastructure was built.
- Numerous **books, publications, podcasts, national recognitions, and even Emmy awards** were generated by Christ Church staff members, as but one indication of the quality of people recruited to or developed by our ministry.
- Annual **contributions** more than doubled, the church's **endowment** and **institutional reserves** rose from \$4.0M to more than \$7.0M and a **generosity/planned** giving ministry was formalized creating great pipelines for the future.
- The largest sum of commitments and expected gifts in a two-year campaign for any church of our size was raised as the result of the **Take Root Initiative** (\$20M of new resources, \$38M overall)—supported by a new department of **Stewardship & Generosity**. Additional efforts like the **LIFT Initiative** followed, raising nearly \$32M over two years.
- Additional **land was purchased** south of the church along York Road and the southernmost plot sold in 2021.
- Extensive **new construction** was completed to support the church's growing ministries:
 - Expanded Kitchen & Storage (2008)
 - Student Center 2 (now grades 4 & 5)
 - Preschool Entrance & new Classroom
 - Sanctuary AV balcony & Media Center
 - Lower Basement (2018)
 - Main Entrance/Foyer (2018)
 - Auditorium Media Center (2018)
 - New Parking & Traffic Flow (2018)
 - Oak & Acorn Rooms
 - Children's Discovery Center
 - Worship Auditorium (2018)
 - Lower Narthex (2018)
 - Elevator (2018)
 - Restroom (2018)
 - New Parking Entrances (2018)
- Substantial **renovations** were performed to improve existing ministry facilities:
 - Chancel
 - Trinity Windows
 - Oak & Acorn Rooms
 - Early Childhood Wing
 - Garden Chapel
 - Garden Plaza
 - Fellowship Hall
 - Children's Classrooms
 - Butterfield Gym
 - Numerous Offices

And God's Word was preached and took root in people's lives through some **1,570 sermon messages**.



Trustee Report

There is a time for everything, and a season for every activity
under the heavens.

ECCLESIASTES 3:1

Dear Members of the Board of Elders of Christ Church,

As we gather at the onset of 2025, we are blessed with an opportunity to reflect on the year 2024 and look forward with hope and purpose. This is a moment to celebrate the incredible ways God has blessed the work of our dedicated staff and volunteers during a remarkable season and to embrace the promise of flourishing in the days ahead.

It is a tradition for the Board of Trustees to begin each meeting with a devotion led by one of our members. At the January meeting, Pete Legan offered a reflection inspired by Ecclesiastes 3, reminding us that there is a season for everything. This reflection prompted each Trustee to consider and share how Rev. Dr. Daniel Meyer has personally impacted each of us during his 28-year tenure as Lead Pastor of Christ Church. While we celebrated Dan's incredible legacy at his final Trustee meeting, we also turned our attention to the future as we continue to prepare for Rev. Steve Carter to lead us into a new season.

2024: A Year of Milestones

The Trustees are entrusted with key financial, administrative, and strategic responsibilities for Christ Church, and 2024 was an especially busy year. Our efforts included:

- Advancing the goals of our Strategic Plan
- Successfully concluding the two-year LIFT initiative
- Partnering with our stewardship and finance teams to ensure the financial health of our church
- Overseeing the search and nomination process for our next Lead Pastor, and
- Conducting a thorough review of our governance documents

Financial Overview

We are deeply encouraged by our congregation's ongoing generosity. To align with the LIFT Initiative, we structured both a traditional annual budget and a multi-year budget for 2023–2024. Our 2024 donation goal of \$14.7 million represented 46% of the cumulative two-year LIFT commitment target of \$31.7 million.

By God's grace, 2023 and 2024 represented an encouraging demonstration of congregational generosity. Total donations of \$31.9 million over the past 24 months exceeded our commitment target by approximately \$250,000. Operating expenses related to staff and programming costs were at budgeted levels during the 2-year period, which reflects our staff's prudent expense management and excellent oversight of our operating areas. Total expenditures during the 2-year LIFT Initiative period (including the debt reduction discussed below) were approximately \$1.7 million higher than originally budgeted due to unique and exciting opportunities we were afforded to invest in our facility's Student Ministry and Preschool areas. The option to increase our commitment to facilities serving our future generation was exhaustively reviewed and debated by the Trustee Board. Ultimately, the Trustees unanimously agreed that investing in these areas was essential for serving future generations, and we elected to utilize a portion of our Institutional Funds to underwrite these additional expenses.

The Trustees also confirmed the utilization of \$2 million LIFT contributions to repay a portion of our outstanding mortgage debt, which was consistent with one of our LIFT goals outlined to the congregation in late 2022. Striking an appropriate balance between reducing our debt and preserving funds for future opportunities requires both detailed financial analysis and thoughtful discernment.

After going through this process, the Trustees validated the initial LIFT goal to allocate sufficient funds, through scheduled principal payments and the \$2 million special payment, to reduce our outstanding debt to \$5 million, a total reduction of \$3 million from the mortgage balance two years ago.

Following this repayment of mortgage debt and the additional investment in the church's facilities, our unrestricted Institutional Fund reserves will be approximately \$4.9 million, slightly higher than our reserve level at the end of 2023. The Trustee Board will continue to prioritize the thoughtful and prudent management of these Institutional Funds, which serve as a "safety net" for our church in times of significant economic uncertainty and as a means to support the church's mission for occasional non-budgeted initiatives.

In conjunction with the Board's Finance Committee and church staff, the Trustees are diligently working on finalizing a 2025 budget that will be presented for congregational approval at the Annual Meeting on March 11.

Lead Pastor Transition

One of the most significant milestones of 2024 was the Lead Pastor search and transition. The Search Committee, co-chaired by Sara Harris and Luke Tenery, conducted a nationwide search, utilizing a thoughtfully constructed Lead Pastor Profile while reviewing nearly 100 applicants. The Committee conducted extensive interviews and ultimately recommended Rev. Steve Carter as their candidate for Trustee consideration. The Trustees also conducted a set of interviews before nominating Steve for a congregational vote. Our membership's 96% affirmative vote reflects both Steve's exceptional qualifications and the thoughtful, prayerful process that guided this decision.

Governance Updates

Our Constitution, crafted 60 years ago, remains a testament to the wisdom of Christ Church's founders. While its theological foundations are as relevant today as ever, the complexity of our operations has grown significantly. Recognizing the need for updates, the Trustees, in collaboration with the Elder Council and senior leadership, have prepared suggested revisions to the governing documents.

These updates are designed to incorporate best practices in governance, enhance operational efficiency, and better support our pastors, staff, lay leaders and congregation. The proposed changes will be presented for congregational approval at the March 11 Annual Meeting, with an opportunity for Elders to provide feedback in advance.

Looking Ahead

As we conclude a fruitful season under Dan Meyer's leadership and move forward with Steve Carter in our Lead Pastor role, the Trustees remain confident in God's guidance for this new chapter. We are committed to supporting Steve, the pastoral staff and the entire Christ Church team as they lead us in fulfilling our mission to make an eternal impact for the Kingdom.

We ask for your continued prayers for Steve, our staff and the countless volunteers who serve faithfully. Your support—through your time, generosity and prayer—is a powerful testimony to this season of flourishing and to the transformative work God is doing through Christ Church.

Let us move forward together, trusting in God's promise to bless all seasons under heaven.

Trustee Nominations

FOR THE OFFICE OF TRUSTEE 2025–2027

Trustees are to be respected disciples with a record of effective service to Christ Church. Normally, they will also be persons with mature experience in the leadership of a large organization. Together with the Lead Pastor, the Trustees are charged by our constitution with responsibility for oversight of the church's staff, finances, facilities, and the other resources and business practices that support the church's ministry and mission.

NOMINATED FOR A SECOND TERM



SARA HARRIS | Member since 2018 and Trustee since 2022 | Sara has been involved primarily in small group ministry and church governance throughout her life. Most recently, she co-chaired the Lead Pastor Search Committee and served on the Elder Council. She was also part of the founding core of the Butterfield campus, where she currently serves on the AV team. Some of her most meaningful ministry experiences have been participating in mission trips with middle and high school students. Sara's professional background is mostly in human resources, having served as Vice President of Human Resources in the food industry. She also served as Executive Director on a church staff. Sara enjoys traveling,

golf, and spending time in nature, as well as cherishing life with her children, stepchildren and two grandchildren.

PHILIP PERZEK | Member since 1986 and Trustee since 2022

Phil and his wife Gayle served in the preschool ministry and have hosted and participated in various small groups over the years. NOMINATED FOR A THIRD TERM

Tim is involved at Christ Church serving on several Board committees, as a co-leader of a small group, and a 25-year participant in Bible Study Fellowship. Tim and his wife Mary live in Hinsdale, have three adult children and two amazing grandchildren.

Christ Church Constitution

Summary of Changes and Key Provisions of New Bylaws

The current Constitution of Christ Church was drafted in 1965 when the church was founded and has been periodically amended by the congregation from time to time to address certain changes as our church body has grown and evolved. The breadth and complexity of Christ Church and its operations and ministries today are significantly different than what existed in 1965. Presently, Christ Church has no bylaws and the current Constitution does not adequately address the array of organizational issues which face a church the size of Christ Church.

About a year ago, a committee of the Board of Trustees began evaluating our Constitution and studied the organizational documents of other large non-denominational Christian churches to divine best practices and structures. After careful consideration over a period of many months, the Board of Trustees concluded that responsible organizational management requires that the Church adopt appropriately tailored bylaws, certain changes to the Constitution and amended articles of incorporation.

Because of the expressed need for bylaws, a number of sections of the Constitution which addressed organizational matters (such as the calling and content of annual and special meetings, certain operations of the Board of Trustees, the Board of Elders, the Elder Counsel and their respective committees and administration of sacraments) be moved from the Constitution into the new bylaws where the same will be aligned with current practices. Other major changes in the Constitution include (i) deleting the requirement that the Lead Pastor be the Chairman of the Board of Trustees, (ii) acknowledging the Board of Trustees' power to set the compensation of the Lead Pastor but making clear the Lead Pastor has primary authority over compensation and employment matters relating to church staff, (iii) clarifying that a limited and designated set of individuals (rather than all Elders) serve as officers of the Church which have authority to legally bind the Church, and (iv) amendments which eliminate the requirement that dismissal of the Lead Pastor requires a vote of two-thirds of the membership and instead delegate the power to dismiss the Lead Pastor to the Board of Trustees under the new bylaws.

CONSTITUTION

Article IV

Article IV, A | Specific details regarding the administration of Baptism and the Lord's Supper were moved out of the Constitution and into the Bylaws (see Section 3.01(c) and (d) (Duties of Elders)). However, the Constitution still notes Baptism and the Lord's Supper as the two Sacraments of the church.

Article IV, B | Clarifies that the Board of Elders should approve all ministries of the church annually i.e., all organizations and their instructors and leaders. However, the requirement that each organization submit a "constitution" to the Board of Elders has been deleted as it was not a procedure commonly followed or required.

Article IV, B9 | Renames the Committee of "Diaconate" to Deacons and makes clear this role of ministerial care and service is to be performed by both men and women.

Article V

Article V, A | Makes certain clarifying changes as to membership, including making explicitly clear that members may be dismissed upon recommendation of the Board of Elders. Additionally, this section makes clear that membership will normally be granted by a public confession of faith in a worship service, but the Minister may otherwise approve membership for an individual in their discretion rather than requiring a letter of recommendation from another church. This change was made after consulting with the pastoral staff on historic practice in this area since such letters of recommendation are largely a thing of the past.

Article VI

This section (Meetings and Fiscal Year) was moved out of the Constitution and into the Bylaws due to the fact that these are primarily corporate (and not spiritual) matters.

Article VI

Article VI, A.1 | Removes the previous minimum and maximum set for number of Trustees and instead clarifies that the Board shall have no fewer than 7 members. (The Bylaws will contain provisions limiting the maximum number of Trustees.) This section also clarifies that each member shall be elected by a majority vote of the Church members.

Article VI, A.2 | This section notes that the Board shall have a Chair (a position now separate and distinct from the Minister), a Vice-Chair, a Secretary and Treasurer, and that these individuals, along with the Minister, shall serve as officers of the Church. This change solidifies a more limited officer group for the Church i.e., a more limited group of individuals that can bind or act on behalf of the Church, which is appropriate for an organization the size of Christ Church.

Article VI, A.6 | Clarifies that the Board shall set the compensation of the Minister, while the Minister, in consultation with the Board or any committee thereof, shall administer the compensation of staff and other employees. This is in keeping with actual practice and clarifies the Board's role is supervisory and not administrative in nature.

Article VI, A.8 | Clarifies that the Board oversees and provides input regarding the hiring and firing of other ministers and professional staff, but that the decision to employ or terminate such minister or professional staff remains with the Minister.

Article VI, A.10 | Revisions to this section add important clarification on decisions that the Board cannot take without approval by a vote of the Church members. For example, it has now been made clear that while the membership must improve any new mortgage on any real property owned by the Church, the Board has the power to amend and refinance any debt which may be secured by such a mortgage lien.

Article VI, B. 1 | Clarifies that members of the Board of Elders shall be elected by a majority vote of the Church members and that each ordained clergy shall be a member of the Board of Elders.

Article VI, B.6 and B.7 | These changes reflect current responsibilities and practices of the Board of Elders.

Article VII

Changes to this section were clarifying in nature e.g., opting for gender neutral language with regard to the Minister.

Article VIII

In conjunction with the revised Articles of Incorporation, which delineates how other Christ Church documents may be amended, this section clarifies that amendments to the Constitution require a three-fourths vote of the Board of Trustees and a vote of not less than two-thirds of the Church members. Importantly, the threshold for amendment is high with regard to the Trustee and member votes that are required, and we feel that this provides adequate protection against hasty amendment of such an important document.

BYLAWS

The goal in adding the Bylaws as a core Christ Church document is two-fold. On one hand, certain organizational functions are more appropriately addressed by the Bylaws (a corporate document that spells out how an organization functions) rather than the Constitution (a spiritual document that identifies the governing philosophies and principles of the Church). For example, how the Church wishes to indemnify officers, trustees, etc. is an important and necessary consideration for the Church, but not a spiritual matter. Second, the addition of Bylaws allows Christ Church to more comprehensively address and capture how the Church should function on matters that are not strictly relevant to the Church constitution. By way of illustration, it is important for the Church to establish rules and guidelines that govern committees of the Board of Trustees, but the frequency of meetings and composition of those committees is not a spiritual matter. Please see below for a few high-level notes on the Bylaws:

Most importantly, this document is intended to supplement the Constitution—not override it. To that end, if the Constitution addresses an issue, we’ve imported the Constitutional language so that anyone reading the Bylaws would know that the Constitution has spoken on this issue. For example, Section 2.02(a) imports the Constitutional section on the number of Trustees and how they are elected.

Note—as in Section 2.02, the Bylaws do provide additional guidelines and/or further clarification for certain matters. Section 2.02, for example, further provides that the Board of Trustees shall generally not have more than 12 members and provides term limits for those members. Importantly, while the Bylaws do offer additional details on certain issues, Article VIII of the Bylaws provides that the Board of Trustees may amend or repeal the Bylaws by a two-thirds vote of the Board of Trustees. This allows the Board of Trustees to continually address areas where additional operating procedures (that are not spelled out in the Constitution) have been included.

Section 2.03(h) | This section clarifies that the Board of Trustees has ultimate authority over the terms and duration of the employment of the Minister. This section adds important clarity around the Board of Trustees’ power (following consultation with certain officers of the Board of Elders) to end the employment of the Minister if compelling reasons are presented rather than seeking a majority vote of the membership.

Section 2.04 | This section details the permanent committees of the Church—the Governance Committee, the Finance Committee, and the Personnel Committee—and identifies committee expectations.

Section 2.06(b) | Identifies that the Board of Trustees shall maintain a Trustee Policy Manual regarding Board vs. Management duties and responsibilities.

Section 3.01(c) | Identifies that the Board of Elders are responsible for administering Baptism and identifies who may be baptized at Christ Church.

Section 3.09 | Provides detail on committees of the Board of Elders, including the Missions Committee and Elder Council.

Article IV | This section of the Bylaws speaks to the duties and powers of the officers of the Church (as opposed to the Trustees or Elders). As detailed by the constitution, the officer group is more limited and is responsible for carrying out the corporate functions of the Church e.g., signing documents.

Article VI | The section on Meetings and Fiscal Year has been imported from the Constitution. Section 6.03 further clarifies that a two-thirds vote of Church members is required for certain important issues.

Amendments to the current Constitution may only be made upon the approval of two-thirds of the members of Christ Church present at a properly called membership meeting. In addition to an affirmative two-thirds member vote, the revised Constitution also requires that any future amendments to the Constitution be supported by an affirmative vote of three-fourths of the Board of Trustees. While the current Constitution contained some language that made certain sections unable to be modified, amended articles of incorporation were filed which legally supersede such limitations and permit the Christ Church members to revise the Constitution in the manner proposed.

It is important to note the faith convictions and covenant expressed in our original Constitution will not change.

The Board of Trustees has worked closely with Rev. Dr. Dan Meyer (Lead Pastor Emeritus), Rev. Rob Kastens (Executive Pastor) and Rev. David Melvin (Executive Director of Ministry Resources) in preparing the revised Constitution, new bylaws and amended articles of incorporation. Since being confirmed, Rev. Steve Carter (Lead Pastor) has reviewed and discussed with the Board of Trustees the proposed changes. In addition, the Board of Trustees consulted with David Lacine (Chair of the Board of Elders) and other members of the Elder Council before the documents were finalized. All members of the senior pastoral staff, Board of Trustees and Elder Council support the revised Constitution, new bylaws and amended articles of incorporation.

ARTICLE I NAME

The name of the Church is Christ Church of Oak Brook.

ARTICLE II PURPOSE

The general purpose of this Church is to conduct and maintain a Church for the worship and service of Almighty God according to the principles outlined in Articles III, IV, and V of this Constitution.

ARTICLE III COVENANT

The Covenant by which the Church exists as a distinct body, and which every member accepts, is as follows:

We profess our decided attachment to that system of the Christian religion which is designated Evangelical.

WE BELIEVE that the Scriptures of the Old and New Testaments are the Word of God and the all-sufficient rule of faith and practice.

WE BELIEVE that there is one and but one living and true God, subsisting in three persons, the Father, the Son, and the Holy Spirit, equal in power and glory; that this triune God created all, upholds all, and governs all.

WE BELIEVE that Jesus Christ is the Son of God, the Savior of the World and that through His life, death, and resurrection, an atonement was made for sin, and redemption was provided for all mankind.

WE BELIEVE that repentance for sin and the acceptance of Jesus Christ as a personal Savior is the one and only way whereby sinful man can inherit eternal life.

WE BELIEVE the Holy Spirit regenerates the soul of the believer and brings man into saved relations with God, and that He is the Comforter and Guide of all who receive Jesus Christ as a personal Savior.

WE BELIEVE in what is termed the "Apostles' Creed" as embodying the fundamental facts of the Christian faith.

ARTICLE IV

THE SACRAMENTS

We believe that Jesus instituted two Sacraments for the edification of the Church: Baptism and the Lord's Supper. These Sacraments shall be administered according to the approved forms and under the supervision of the Board of Elders.

MINISTRIES

All organizations, instructors, and leaders of the Church must be approved by the Board of Elders annually.

ARTICLE V MEMBERSHIP

Any person may be received into or dismissed from membership upon recommendation of the Board of Elders. Except as the Minister may otherwise approve, membership will be granted upon public confession of faith made in a worship service of the congregation.

The duties of the members of this Church are set forth in the Membership Covenant approved by the Board of Elders as set forth in the bylaws of the Church but shall include, without limitation, the following:

To attempt to live in all their relationships according to the spirit and teachings of Jesus as revealed in the Bible.

To attend faithfully the services of worship of this Church.

To contribute to its support, its missionary program, and benevolences according to the principles of Christian stewardship.

To share in the organized work.

Members who move from this congregation shall be encouraged to affiliate with another church which is true to God's Word. The Board of Elders shall have authority to grant letters of recommendation.

ARTICLE VI ADMINISTRATIVE BODIES AND OFFICERS

BOARD OF TRUSTEES

The Board of Trustees (the "Board" or "Board of Trustees") shall consist of not less than seven members. Each member shall be elected at a meeting of the Church by a majority vote of the Church members and shall serve for a three-year term.

The Board shall elect officers annually from among themselves including a Chair, Vice-Chair, Secretary, and Treasurer. The Minister, Chair, Vice-Chair, Secretary and Treasurer shall also serve as the officers of the Church.

The Board shall make a report of its work to the Church body at its annual business meeting and submit such recommendations as it may deem necessary and desirable.

The Board shall prepare nominees for the Board for the annual business meeting of the Church.

The Board shall prepare and submit to the Church body at its annual business meeting for its consideration and action, budget showing estimated income and proposed expenditures. The securing of funds necessary to meet the current expenses shall be under the direction and control of the Board.

The Board shall set from time to time the compensation of the Minister, while the Minister, in consultation with the Board or any designated Committee of the Board, shall administer the compensation of staff and other employees of the Church.

The Board shall prepare a nomination for the Minister of the Church in the event of a vacancy.

The Board shall be responsible for maintaining oversight over and input regarding the employment or termination of employment of the other ministers and professional staff which are undertaken by the Minister.

The Board shall be responsible for maintaining the legal status of the Church, and its members shall be deemed the "Directors" described in the articles of incorporation of the Church.

The care, custody, and control of the real and personal property of the Church is vested in the Board, and the Board is authorized and empowered to take such steps as are necessary or proper to protect the properties of the Church and its interests therein; to make such repairs, improvements, and alteration of the properties of the Church, and to provide for such maintenance work on said properties as shall be necessary or proper to maintain and keep them in good, safe, and serviceable condition; to regulate and control the use of the properties of the Church; to arrange for annual and special audits by a competent auditor of the books and records of the Treasurer of the Church; to invest funds of the Church, which in the opinion of the Board are not required for current payments or expenses, in such securities as may be lawful investments; to accept or reject on behalf of the Church, gifts, bequests, devises, or trusts, and to determine the manner in which said gifts, bequests, devises, or trusts shall be expended or invested, provided that whenever a condition or direction as to its use is provided for in any such gift, bequest, devise, or trust, it shall be scrupulously complied with; to enter into or make such contracts, deeds, and other instruments as may be necessary or appropriate to carry out the powers and duties of the Board; and to exercise such other powers and perform such other duties as are provided for elsewhere in this Constitution or by law; provided, however, that the Board shall not have power, unless authorized or directed to do so by vote of the Church members, to (1) sell or convey, mortgage, or encumber any real estate of the Church or any interest therein (but excluding any amendments, restatements and/or refinancings associated therewith), (2) erect, construct or enlarge any building (but may without any such membership vote, remodel, renovate and/or repurpose such buildings) or (3) purchase any real estate or interest therein. The Chair, Vice Chair, Treasurer, Secretary or assistant secretary (if any) of the Board or other party authorized by the Board shall have power to execute in the name and on behalf of this Church all contracts, deeds, and other instruments authorized by the Board or by the Church.

The Board shall appoint such Committees as are needed for the proper administration of the Church. A list of nominees for the Committees and their Chairs shall be prepared by the officers and ratified by the Board. Except as may be otherwise provided in the Bylaws of the Church, committee members need not be members of the Board.

Members of the Board of Trustees shall serve as members of the Board of Elders.

BOARD OF ELDERS

The Board of Elders (the "Board of Elders") shall consist of not less than nine members who shall be elected at the annual business meeting of the Church by a majority vote of the Church members for a term of three years. In addition, each ordained clergy of the Church shall be deemed to be members of the Board of Elders.

The Board of Elders shall elect annually a vice chair and a secretary of the Board of Elders. The Minister shall serve as the chair of the Board of Elders.

The Board of Elders shall prepare a list of nominees for the Board of Elders to be presented at the annual business meeting of the Church.

The Board of Elders shall be the advisors of the Minister as to the spiritual interests of the Church.

The Board of Elders shall assist the Minister in overseeing the administration of the Sacraments of the Church, and shall make the necessary preparations for their observances (see Art. IV:A).

The Board of Elders shall be responsible for fostering and promoting the servant ministry and external missions of the Church including, but not limited to, the selection and oversight of mission partners and approval of the annual mission budget of the Church.

The Board of Elders, in consultation with the ministerial staff, shall deal with matters of member discipline.

The Board of Elders shall appoint such other Committees as may be necessary in the discharge of their responsibilities. Members of such other Committees need not be members of the Board of Elders.

Among the Committees appointed by the Board of Elders shall be one consisting of deacons (male and female) with the following duties:

To assist the ministerial staff in visiting and aiding the sick, needy and bereaved.

To assist in the preparation and administration of the sacrament of communion.

ARTICLE VII THE MINISTER

The Minister shall be elected by the members of the Church from a nomination presented by the Board of Trustees.

The duly elected Minister shall be installed by the Board of Elders at a regular worship service of the Church.

The Minister shall have the spiritual oversight of the membership; shall have charge of the exercises of public worship; shall administer the Sacraments; shall preach the Word; shall be the leader of devotional meetings of the Church; and shall perform such other duties as usually pertain to this office.

The Minister shall be a member of the Board of Trustees and the Chair of the Board of Elders, and an ex officio member of all committees.

The Minister shall be the executive head of the Church staff and employees.

The Minister shall make a report of the work of the Minister at the annual business meeting of the Church.

The Minister shall conduct his/her life in keeping with the office of the Minister and shall preach and teach in harmony with the Scriptures and the Church Covenant

ARTICLE VIII AMENDMENTS

This Constitution may be amended only upon (i) an affirmative vote of not less than three-fourths of the Board of Trustees and (ii) an affirmative vote of not less than two-thirds of the voting members present at an annual business meeting or at a special meeting called for that purpose, provided that due notice of such proposed amendment has been given at least one month prior to such meeting by means of the most prevalent existing method through which the Church communicates with its members, including, but not limited to, electronic mail or other similar electronic communication. Voting on all amendments shall be by ballot.

2024 Treasurer's Report

Christ Church Stewardship of Financial Resources

The Treasurer and Finance Committee are dedicated to maintaining strong stewardship of the financial resources contributed by the congregation to meet our ministry, missional and capital needs. Following is a summary of the full two-year LIFT initiative, which demonstrates a strong commitment from the congregation, as well as incremental use of institutional funds to prepare the Church for the future.

We praise God for the faithfulness of our congregation for their continued financial support of Christ Church. Operating expenses related to staff and programming costs were at budgeted levels during the 2-year period, which reflects our staff's prudent expense management and excellent oversight of our operating areas. Total expenditures during the 2-year LIFT initiative period were approximately \$1.7 million higher than originally budgeted due to unique and exciting opportunities we were afforded to invest in both the Student Ministry and preschool areas of our facility. The option to increase our commitment to facilities serving our future generation was exhaustively reviewed and debated by the Trustee Board. Ultimately, the Trustees agreed that investing in these areas and reducing our debt was essential for serving future generations and we elected to utilize a portion of our Institutional Funds to underwrite these additional expenses.

For 2025, the finance committee and the Trustees have been working in conjunction with the staff to develop a recommended budget informed by our recent giving patterns and acknowledging the completion of the LIFT initiative. The significant components include funding of Ministry Operating expense of \$12.4 million, Missions expenditures of \$1.2 million and Capital expenditures of \$3.4 million, which includes normal principal and interest payments on debt of \$0.3 million and normal maintenance capital of \$0.3 million, with the remaining funds dedicated to LIFT capital work of \$2.8 million (\$2.0 million January debt reduction, \$0.4 million Campus Quality and \$0.4 million Lift Center completion). The Capital Budget has been approved by the Trustee Board and the Mission Budget has been approved by the Elder Board.

Over the years, Christ Church has built up and utilized, as appropriate, various funds designated as our Institutional Fund reserves. As a Trustee Board, we are committed to build these reserves in times of plenty so that they are available for strategic initiatives as well as a backstop, when necessary, against shortfalls in revenues.



2025 Mission Report

2024 was a year of exciting momentum in the Mission ministries of Christ Church. God was on the move through our people and our partners, bringing relief, life change and the Good News of the Gospel to thousands.

Our Global and Domestic Missions MMAs disbursed more than \$826,000 of ongoing support to mission partners last year. Serving across the United States and from Costa Rica to Kenya to China and beyond, we are humbled by our partners' faithful work to Lift Women & Children, Relieve Suffering, Transform Communities, Develop Leaders and Multiply Churches & Disciples. Additionally, Christ Church mobilized \$294,000 of Discretionary Funding through grants, new initiatives and disaster relief in Chicagoland and abroad. \$65,000 of Global Disaster Relief offered rescue and restoration to victims of flooding in Kenya, political strife in Haiti and persecution in India. More than \$44,000 of Domestic Disaster Relief provided aid in the wake of Hurricanes Helene and Ian, devastating wildfires in California and more.

We were also humbled by the Missional Living of Christ Church people in 2024, as global Outreach Teams traveled to India, the Dominican Republic, Romania and Malawi. Here at home, 23 Administer Justice volunteers offered affordable legal assistance to 48 clients at our Gospel Justice Center. Twenty Christ Church adults provided Christian mentorship to elementary students through the Kids Hope program. Our FOR Chicagoland "First Saturday Serve" days saw volunteers delivering groceries to seniors with Breakthrough, preparing meals for DuPage PADS and fellowshipping with English-learners at our English Conversation Café. And October's FOR Chicagoland Annual Day of Service saw nearly 600 people scattered throughout the city and suburbs to serve 40 community organizations and mission partners.

During the FOR Christmas giving initiative, you gave more than \$70,000 to mission partner projects — along with over 1,000 candy stockings and more than 1,600 presents. Through our partners, the donated gifts were given to children in need by their parents, strengthening families.

In September we celebrated the 20-year anniversary of the Food Pantry Ministry, which has served more than 100,000 people with food, clothing, Bibles and prayer. After operating in the Salvation Army gym for many years, this ministry will find a permanent home at the Lift Center, opening at our Butterfield campus in the spring. We are thrilled to bring all of these need-meeting ministries together under one roof—a paradigm shift made possible by your generosity through LIFT.

The story of God's faithfulness continues in 2025. We look forward with eagerness to all that He will do in and through us in this exciting new chapter. We thank God for the privilege of joining Him in this work—and thank you for your generosity in making it possible!
